

Wiggle Waggles Doggy Daycare Customer Agreement

1. All dogs must be at least 12 weeks of age and fully weaned.
2. Dogs must be able to play nicely with others. If your dog just needs some work on socialization we can work on that for you. If we find that we are unable to integrate your dog into one of our play groups we regret that they will not be allowed to stay.
3. When dogs are excited they tend to bark. If your dog becomes a nuisance barker we will require that they wear a vibrating collar to help remedy this behavior as the City of Anacortes has a barking ordinance. The collar does not shock your dog it only vibrates. If the barking continues and a solution cannot be found your dog will regrettably not be allowed to remain.
4. Dogs will be given on-leash bathroom breaks every 2-3 hours while staying with us. We will use a martingale collar to prevent accidental escape during these breaks.
5. All dogs must be vaccinated with rabies, DHLPP and bordetella (as age appropriate per your vet). Owners are required to bring in proof of vaccination. All dogs must also be healthy upon arrival. If a dog is determined to be sick we will regrettably have to turn you away for that day. Your dog can return when he/she is healthy again. Your dog may catch a bug from other dogs it socializes with at our facility. We will not be responsible for any diseases your dog contracts while at our facility.
6. Even when dogs are well socialized they can still get into fights. We will make every effort to stop the fight without making physical contact. This includes distracting with noise or treats. If the dogs don't stop with distraction we will have to resort to physically separating the dogs. We will not be responsible for injuries caused by your dog or for injuries your dog suffers because of another dog's aggression.
7. If your dog gets injured or violently ill while in our care we will call you and you must be able to take them to the vet for treatment. We can stabilize their condition while we wait for you to arrive, but are unable to leave the facility to take your dog to the vet. If your dog must be taken to the vet you will be responsible for the bill.
8. Our hours of operation are M-F from 7:15-5:30p. If your dog has not been picked up by 5:30p and we have been unable to contact you then your dog will be taken to our home for the night and you can pick them up the next day. If you do not pick them up by the end of the next day we will have to turn your dog over to the appropriate party. There is also an after hours pick up fee that will apply to this as well as last pick ups.
9. We will give your dog treats for good behavior. The treats will be infrequent and usually from a healthy all natural source. If your dog has special dietary requirements you must notify us upon drop off.
10. Dogs can be hard on furniture or houses. We realize this. However, if your dog continually causes excessive damage to our facility or property, we will work with you to find a solution. If the destructive behavior continues we may have to ask you to discontinue bringing your dog. For excessive damages we may hold you responsible for repair or replacement costs.
11. Some dogs are escape artists. We will do our very best to ensure that your dog is not in a position to leave our property on its own. If your dog manages to run away from our facility we will contact you immediately. We will also contact the Anacortes Animal Control officer. We will not be held responsible for lost or runaway pets placed in our care.

12. Anacortes city residents are responsible for licensing their dogs. We will assume if you live in city limits you have properly licensed your dog.

13. We will occasionally take pictures/videos and post them on our website or to social media. Please let us know if you prefer we not use images of your dog.

14. Dogs must be spayed/neutered by the time they are 1 year old.
